## **COLUMBARIUM INURNMENT SUBSCRIPTION APPLICATION**

The Columbarium and Memorial Garden of The Cheshire Evangelical Lutheran Church (the "Church") are located at 660 West Main Street, Cheshire, Connecticut, and are an ongoing ministry of the Church.

The Columbarium Wall provides niches for the placement of the cremains of loved ones and plaques to memorialize them. Each niche has space for one (1) urn, so please complete a separate Columbarium Inurnment Subscription Application ("Application") for each inurnment requested.

The Application consists of three parts:

- Part 1: Application for Rights to Inurn
- Part 2: Niche Plaque Order Form
- Part 3: Fees and Signatures

### PART 1: APPLICATION FOR RIGHTS TO INURN

### **Subscriber Information:**

- 1. The Subscriber is the person who is applying for the rights to inurn.
- 2. The Subscriber may be the same person whose cremains are to be inurned within the Columbarium Wall.
- 3. The person whose cremains are inurned within the Columbarium Wall is called the "Decedent".

### **PART 3: FEES AND SIGNATURES**

### **Columbarium Inurnment Subscription Fee**

As detailed on the attached Columbarium and Memorial Garden Schedule of Fees, the Columbarium Inurnment Subscription Fee is \$1,700, and covers the costs of the exclusive rights to use the niche (which has space for the inurned cremains of one person); inurnment; and the purchasing, inscribing, installing, and maintaining the niche plaque. The fee will also be used to maintain the Columbarium and Memorial Garden to preserve their beauty and integrity.

The Subscription Fee is broken down as follows:

Niche Fee:	\$1,000
Inurnment Fee:	350
Niche Plaque Fee:	350
Subscription Fee	\$1,700

These fees are subject to change until paid; therefore, it is recommended that the Subscription Fee be paid in full at the time of application to take advantage of current fee pricing. If the Subscription Fee is not paid in full at that time, the Niche Fee of \$1,000 must be paid, and the balance due (consisting of the Inurnment Fee and the Plaque Fee) must be paid in full at the time of filing the Application for Inurnment of Cremains.

- 1. Checks are payable to "Cheshire Lutheran Church".
- 2. If the Church does not approve this Application, all fees paid by the Subscriber will be refunded.
